AGREEMENT (ALL)

Initials **In consideration of this opportunity to become a member, volunteer or JCHSI foster family, I agree to the following terms and conditions, intending to be legally bound by them:**

1. I agree to abide by JCHSI’s mission, rules, regulations, policies and programs while I am a member, volunteer or foster family. I understand that failure to do so may result in my immediate termination as a member, volunteer or foster family.
2. If I stop being a JCHSI member, volunteer or foster family for any reason, or upon JCHSI’s request at any time, I agree to promptly return all of JCHSI’s supplies, equipment, records, monies, and other items in good, clean condition.
3. Should my volunteer activities involve contact with or working in close proximity to any animals directly or indirectly under the control of, or associated with the JCHSI, I shall assume any and all risks encountered, including but not limited to being bitten, scratched, injured or frightened.
4. JCHSI is not liable to me for any injuries, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with my performing volunteer activities for JCHSI. I will indemnify, defend and hold JCHSI harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever, sustained by any companion animal or any person in connection with my intentional misconduct or grossly negligent performance of volunteer activities for JCHSI, or my breach of JCHSI rules, regulations, policies and programs.
5. I understand and agree that JCHSI may refuse applications for any reason.
6. If I will be sheltering or providing foster care, or boarding any JCHSI animals in my home or business, I consent to JCHSI visiting my home or business from time to time to observe the animals and their living quarters.
7. I have accurately and truthfully completed this Application and Agreement.
8. I agree to keep confidential all information learned about JCHSI clients while serving as a member, volunteer or foster family.
9. Any modification to this agreement must be signed in writing, signed by both parties. This Agreement is binding upon JCHSI, me, and JCHSI’s and my respective heirs, successors, assigns, executors and personal representatives.
